The <u>Human Rights College Tour (HRCT)</u> is a joint initiative of the Liberation Committee 1945 Wageningen (*Comité 4 en 5 mei Wageningen*) and the Public Administration and Policy Group of Wageningen University and Research Centre.

During four evening sessions, fundamental questions about the current human rights doctrine will be addressed from different angles (juridical, NGO, business, political), in order to revitalize and possibly redirect the human rights debate. The HRCT has invited speakers from different sectors, who are all working in the field of human rights. They will discuss

- (a) what they see as trends in human rights development and
- (b) whether human rights as a set of agreements between states to respect the dignity of every individual on their territory has become outdated in a world of globalization characterized by the emergence of NGOs and multinational business as new duty bearers or sovereignties. Or whether the discourse can still be considered the corner stone of international order and a safety valve to prevent abuse of the state monopoly of violence.
- (c) what the most important strategies or steps are to contribute to immediate or progressive realization of human rights.
- (d) to what extent the distinction between Economic, Social and Cultural rights, and Civil and Political rights has formed an impulse or rather a barrier for the realization of human rights.
- (e) whether it is important and feasible to make the existing human rights doctrine work better or a need to review, revitalize or even break down the existing human rights doctrine with a view to develop new human rights.
