Background A consensus is building that tackling obesity effectively requires a whole system approach where a range of measures focusing on individuals, social and other systems, and the role of local authorities in realising much of this is key. 2. Aim

Public Health England (PHE) is looking to commission an organisation or consortium of organisations to support Local Authorities in England in working to implement whole systems approaches to tackling obesity and reducing associated inequalities. This is a major programme of work that will take place over 3-4 years.

3. Intended outcomes

- Consensus on key elements of a whole system approach to obesity and statements and tools on what constitutes best practice.

— An evidence based approach.

— Increased knowledge, confidence and capability among local authorities of what constitutes an effective whole system approach for their area.

- Tools and resources to build and implement whole system approaches.

— An increased number of local authorities (from 2014 baseline) who are adopting or moving towards having a whole system approach in place.

4. Minimum expectations

Evidence building and framework/tool-kit creation

- A review of relevant national and international evidence on system wide approaches to tackling obesity, including localised approaches.

- Identification and investigation of existing whole systems practice to tackling obesity that are in place across England.

— Creation and testing of a generalisable framework that can be used by Local Authorities to establish and develop a whole systems approach to tackling obesity.

Supporting local approaches

- Close collaboration with Local Authorities, their partners and local communities to discern what elements of a whole system approach they have in place, and identify what further they can do.

- Creation and dissemination of set of innovative and adaptive tools to support and sustain these activities.

5. Expectations of potential providers

PHE is looking for an organisation or a consortium of organisations to deliver this programme. The key expectation is that providers are able to leverage expertise and experience across all areas of a whole system approach to obesity and this would need to include access to public realm, spatial planning and transport expertise as much as nutrition, physical activity and regulatory approaches possible at local level. Consortia may include a wide range of organisations, such as academic, social research/marketing, social enterprise, commercial and third sectors.

It is essential that any bidders demonstrate forward and lateral thinking and innovative approaches. Any bidders must have and demonstrate significant experience of working with Local Authorities and their communities.

Local Authorities for the purposes of this programme is defined as Principal Local Authorities as defined by section 28 of the Local Government Act 1992 which means Unitary Councils (e.g. London Boroughs, Metropolitan districts etc.) County and District/Borough Councils and their partners. Parish and Town councils are likely to be important local partners for these principal councils.
